LOCAL APPOINTMENTS LIST - TERMS EXPIRING JANUARY 15, 2006

Commissions, boards and councils are advisory to the City Council. Commission appointments are made by the City Council as a whole at a public meeting in January. Applicants must be registered voters in the City of Torrance and serve four-year terms. Commissioners may serve up to two consecutive terms. Commissioners appointed to fill unexpired terms may serve two consecutive terms in addition to completion of the unexpired term. (**Exception -- Commission on Aging per Ordinance 3407)

Compensation is made for expenses at \$10 per meeting attended with most agencies meeting once a month. (Refer to specific commission for meeting days.)

Commission applications are accepted at any time throughout the year. Notices of unscheduled vacancies are posted in the City Clerk's office, the City Clerk's Bulletin Board and the Civic Center Library within twenty days of the vacancy. At least ten working days notice will be given before any unscheduled vacancy is filled. Notice is given through advertising in the *Daily Breeze*, announcements at Council meetings, on Torrance CITICABLE and notice to homeowners associations.
