MINUTES OF AN ADJOURNED REGULAR
MEETING OF THE CITY COUNCIL OF
THE CITY OF TORRANCE

The City Council of the City of Torrance convened in an Adjourned Regular Meeting in the Council Chamber, City Hall, Torrance, California, on Monday, August 26, 1940 at 5:00 P.M.

Mayor McGuire called the meeting to order.

Clerk Bartlett called the roll, those answering present being Councilmen: Babcock, Hitchcock, Murray and McGuire. Absent: Councilmen: Powell.

Being an adjourned meeting, the regular order of business was dispensed with.



Councilman Hitchcock moved that the bid of Crane Company be rejected and returned unopened for the reason that said bid was received at 5:25 P.M., too late to comply with the instructions set forth in "Instructions to Bidder". Councilman Murray seconded the motion, which was carried unanimously.

Councilman Hitchcock moved all bids be referred to the City Council as a whole, the Acting City Engineer and the Manager of the Water Department for consideration and report at the next meeting. Councilman Babcock seconded the motion, which was carried unanimously.

Councilman Hitchcock moved that the members of the City Council and other City employees approved by the City Council, be authorized to attend the State Convention of the League of California Cities on September 16, 17, 18 and 19, 1940 at San Diego, expenses paid. Councilman Murray seconded the motion, which was carried by the following roll call vote. AYES: COUNCILMEN: Babcock, Hitchcock, Murray and McGuire. NOES: COUNCILMEN: None. ABSENT: COUNCILMEN: Powell.

At 5:30 P.M., upon motion of Councilman Hitchcock, seconded by Councilman Murray, the meeting adjourned.
