MINUTES OF AN ADJOURNED REGULAR MEETING OF THE TORRANCE CITY COUNCIL

The Torrance City Council convened in an adjourned regular meeting on Thursday, May 14, 1970 at 4:00 P.M. in the Council Chambers at Torrance City Hall.

1. ROLL CALL:

Responding to roll call by City Clerk Coil were: Councilman Brewster, Johnson, Sciarrotta, Surber, Uerkwitz, Wilson, and Mayor Isen.

2. DISPENSATION WITH REGULAR ORDER OF BUSINESS:

Councilman Sciarrotta MOVED to dispense with the regular order of business. His motion was seconded by Councilman Surber, and there were no objections.

3. PURPOSE OF MEETING:

Mayor Miller explained to the large audience of Commission applicants that this meeting has been called for the purpose of appointing Commissioners to the Airport, Park and Recreation, and Planning Commissions. Their enthusiasm and interest was gratefully acknowledged by Mayor Miller.
