MINUTES OF A REGULAR MEETING
OF THE BOARD OF TRUSTEES
OF THE CITY OF TORRANCE.

A regular meeting of the City Council of the City of Torrance, was held in the Council Chambers of Torrance, California, July 19th, 1927, and was called to order at 7:45 P.M. by President Dennis.

The following Trustees were present: Conner, Inman, Wolfe, and Dennis. Absent: Raymond.

The minutes of the regular meeting of July 5th, 1927, were read and approved as read.

The Clerk read a letter from the Atchison, Topeka, and Santa Fe Railway Company under date of July 16th, 1927, regarding the paving of the Sonoma Street Crossing. The estimated cost was \$142.22.

Councilman Wolfe moved that the City Engineer be instructed to have the Sonoma Street crossing put in, at an estimated cost of \$142.22. Councilman Inman seconded the motion which was duly carried by the following roll call vote:

ABSENT: Trustee Raymond.

The letter from the City Planning Commission under date of June 15th, 1927 was ordered filed on motion by Councilman Inman seconded by Councilman Wolfe and carried by a majority vote.

A letter was received calling attention to the new law governing Fifth and Sixth Class Cities, changing Trustees to Councilman, and the President of the Board to Mayor.

Engineer Leonard reported that a request had been received for definite information as to whether the Western Avenue Auto Camp building permit was revokable, and if not, could additional houses of the same type be built. The Engineer and the City Attorney wish to look this matter up.

Attorney Briney read:
