ADVANCE NOTICE OF CONSTRUCTION

CITY OF TORRANCE

Dear Homeowner/Resident:

This Notice is to inform you that starting on Tuesday, August 13th, the City's contractor, VSS International, Inc., will begin "Cape seal" treatment on your street and/or streets in your neighborhood. "Cape seal" is a two-phase process that will occur over a 7-day timeframe. Phase 1 is the application of liquid asphalt, sand and aggregate. The material will appear unsmooth; however, it must cure for approximately 5 days. Subsequently, the contractor will then apply Phase 2, which is the final slurry seal. Cape seal extends the life of the street and improves its appearance.

A map and schedule of the work for Tuesday, August 13th through Friday, August 16th is on the other side of this Notice. Two (2) days prior to performing work on your street, the City's contractor will provide you with another notice as a reminder of the specific day that your street will receive the first application. You will receive an additional set of notices before the second application. Be advised that the schedule may change due to inclement weather; however, the City intends to always provide adequate notice of work.

TRAFFIC IMPACTS & ACCESS

To properly apply cape seal, **each street must be closed from 7:00 a.m. until 4:30 p.m. to allow for the application and drying process. No vehicles will be allowed on your street until the work is complete.** Access to and from your driveway will also be prohibited. If you need to use your vehicle, we suggest you park it on another nearby street, not in the work area. Temporary "NO PARKING" signs, with the date and time of the parking restrictions, will be posted 48 hours in advance of the work. **Please move your vehicle off the street by 7:00 a.m. or your vehicle will be towed at your expense.**

WET CAPE & SLURRY SEAL WILL STAIN. Walking or driving on wet slurry will leave unsightly tracks on the roadway, stick to shoes, and stain car finishes and driveways. **Please do not drive or walk on the slurry seal until the contractor has removed all barricades and traffic cones, which will indicate the street is open to vehicles and pedestrians. If you have a special need (i.e. medical appointment, delivery, etc.) please contact the Project Engineer or Inspector so they may try to accommodate you.** We thank you for your cooperation and patience.
