SECTION 300 - EARTHWORK

300-2.1 General. Add the following text:


Roadway Digouts:

Unclassified excavation of existing AC pavement and underlying materials will be required as directed by the Engineer. City staff will inspect the pavement condition to identify the locations and extents of each area. The minimum width of an area is expected to be no less than 8 feet and within a single travel lane. The City anticipates approximately 20 Dig Out areas, the smallest of which measuring approximately 200 SF.

300-2.9 Payment. Add the following:

Measurement & Payment for the removal and disposal of bituminous pavement and unclassified excavation to a total depth of 10 inches below existing roadway grade shall be considered as included in the Contract Unit Price for **DIG-OUTS** as measured in the field and shall include sawcutting, removal of underlying subgrade and base, disposal, subgrade preparation and compaction, placement & compaction of 6 inches of CMB, placement & compaction of 4 inches of Type B-PG-64-10 Asphalt Concrete, application of tack coat, and all labor and equipment.

Slurry seal shall be quick-set emulsion-aggregate slurry (EAS), with the addition of 2.5% latex, and is herein referred to as “Slurry.”

Type I Slurry shall be used in City Parking Facilities.

Type II Slurry shall be used on all residential and arterial streets.”




