FILE STATEMENT OF ECONOMIC INTEREST Incoming and outgoing elected officials must file the Statement of Economic Interests (Form 700) within 30 days of assuming or leaving office; last day to file.

The first day for **sample ballot pamphlets** to be mailed is May 10, 2010 with the last day being June 1, 2010. Sample ballot pamphlets may be mailed in batches and not be sent until the last day. It is suggested that if at all possible the voter wait until the sample ballot pamphlet arrives.

No Vote by Mail ballot may be mailed before May 10, 2010. The last day to apply for a regular Vote by Mail ballot is June 1, 2010.
