MINUTES OF AN ADJOURNED REGULAR
MEETING OF THE CITY COUNCIL
OF THE CITY OF TORRANCE

The City Council of the City of Torrance convened in an Adjourned Regular Meeting in the Council Chamber, City Hall, Torrance, California, on Thursday, June 3, 1948, at 8:17 p.m.

Mayor Sherfey called the meeting to order.

Clerk Bartlett called the roll, those answering present being Councilmen: Haggard, Powell and Sherfey. Absent: Councilmen: Drale and Jackson.

Mayor Sherfey announced that this being an adjourned meeting, the regular order of business would be dispensed with.

A communication was read from Leland J. Franz, 1820 Middlebrook Road, Torrance, asking favorable consideration of his application for a license to operate a private patrol service in the Kettler Knolls Tract.

A communication was read from the Kettler Knolls Property Owners Ass'n advising that the property owners in that area are desirous of subscribing to said patrol service.

Councilman Powell moved that Mr. Franz be granted a license to operate a private patrol service in the Kettler Knolls Tract. Councilman Haggard seconded the motion which was carried unanimously.

Clerk Bartlett presented for first reading and read title to:

ORDINANCE NO. 404

AN ORDINANCE OF INTENTION TO ORDER THE
VACATION OF A PORTION OF THE ALLEY SHOWN
AS LOT A-27 OF BLOCK 27, TORRANCE TRACT,
AND REPEALING ORDINANCE NO. 403.

Councilman Powell moved that further reading of Ordinance No. 404 be dispensed with. Councilman Haggard seconded the motion which was carried unanimously.

Councilman Powell moved that Ordinance No. 404 be adopted for first reading. Councilman Haggard seconded the motion which was carried by the following roll call vote: AYES: COUNCILMEN: Haggard, Powell and Sherfey. NOES: COUNCILMEN: None. ABSENT: COUNCILMEN: Drale and Jackson.

City Administrator Stevens presented Final Tract Map No. 15211, submitted by Sunhaven Properties, Inc., and advised that the Planning Commission unanimously approved said Tract Map No. 15211 with the recommendation that the City Council concur in this action.

Councilman Powell moved that the Council concur in the action of the Planning Commission in approving Final Tract Map No. 15211. Councilman Haggard seconded the motion which was carried by the following roll call vote: AYES: COUNCILMEN: Haggard, Powell and Sherfey. NOES: COUNCILMEN: None. ABSENT: COUNCILMEN: Drale and Jackson.

At 8:21 p.m. Councilman Jackson took his seat at the Council Table.

Councilman Powell moved that all bills properly audited be paid. Councilman Haggard seconded the motion which was carried by the following roll call vote: AYES: COUNCILMEN: Haggard, Jackson, Powell and Sherfey. NOES: COUNCILMEN: None. ABSENT: COUNCILMEN: Drale.

At 8:22 p.m., upon motion of Councilman Powell, seconded by Councilman Haggard, and unanimously carried, the meeting adjourned.
