Please note the following changes and/or additions to the Bidder's Submittal, Plans and/or Specifications for the project indicated above. The bidder shall execute the Certification at the end of this addendum, and shall **attach this addendum to the Contract Documents submitted with the Bid**. In addition, the bidder shall complete and submit the "Acknowledgment of Addenda Received" Form provided in Section C of the Specifications.

1. **Refer to Section A, NOTICE INVITING BIDS on page A-1:**

The first paragraph is hereby revised as follows to reflect a new bid opening date:

*"Notice is hereby given that sealed bids for performing the following described work will be received at the Office of the City Clerk of the City of Torrance, California, until 3:00 p.m. on **Wednesday, June 15, 2016** ~~Wednesday, June 1, 2016~~, after which time they will be publicly opened and read at 3:15 p.m. in the Council Chambers of said City."*

2. **Refer to Bidder's Submittal on pages C-1 through C-3 of the Specifications and in the official Bidder's Submittal package provided by the City Clerk:**

Bidder's Submittal Pages C-1 through C-3 (3 pages) is hereby deleted in its entirety and replaced with the new Bidder's Submittal pages C-1, Addendum No. 1 through C-3, Addendum No. 1 (3 pages) which is attached to this addendum. A Bidder must use the new Bidder's Submittal pages C-1, Addendum No.1 through C-3, Addendum No. 1 in its bid.

3. **Refer to Section E, Special Provisions, Section 217-4.1 General, Page E-35:**

Delete Section 217-4.1 General in its entirety and replace with the following:

"217-4.1 General.

An Automatic Retractable Screen (ARS) prevents trash and debris from entering the catch basin during dry weather and moderate storm flows, thereby maintaining trash and debris within the street to be collected by street sweeping and other equipment. It shall open automatically to restore the curb opening with minimal obstruction when the depth of the storm flow in the street exceeds 3 inches.

The mechanism for automatically opening the screen shall be any mechanism that collects storm water in a container and uses the weight of that water to operate moving parts that cause the screen to open. The following is a list of Automatic Retractable Catch Basin Screen model and manufacturer accepted by the Los Angeles County

Department of Public Works for minimum reduction in Catch Basin Hydraulic Capacity and the City of Torrance:

Bidders are advised that the listing of devices by name in these Special Provisions does not exclude the device from meeting all requirements of these Special Provisions. There shall be no exceptions to this requirement and acceptance of devices not listed in these Special Provisions shall be at the sole discretion of the Engineer. Products not listed above must be approved by Los Angeles County Department of Public Works to be considered as "or equal" and meet all requirements of these Special Provisions."

4. **Refer to Section E, Special Provisions, Section 3-2.6 Allowances, Page E-7:**

The third paragraph is hereby deleted:

~~*"The Agency has established an allowance to repair damaged catch basins. Payment for repair of damaged catch basins will be made on the basis of "Extra Work" per 3-3 of the Additions and Amendments. Payment will be made under the item in the Contract Lump Sum bid item for RECONSTRUCTION OF LOCAL DEPRESSION FOR CATCH BASIN ARS (ALLOWANCE OF \$10,000)."*~~

The following paragraph is hereby added in its place:

"The Agency has established an allowance to modify or repair existing damaged catch basins for installation of ARS units. Payment for repair of damaged catch basins will be made on the basis of "Extra Work" per 3-3 of the Additions and Amendments. Payment will be made under the item in the Contract Lump Sum bid item for 'RECONSTRUCTION OF LOCAL DEPRESSION FOR CATCH BASIN ARS.'"
