Qualified Environmental Consultants List

In accordance with the California Environmental Quality Act (CEQA), the City of Torrance is the Lead Agency that oversees the environmental review of development projects within its jurisdiction as well as major land use decisions that require discretionary approval. Applicants for private development projects are responsible for directly selecting and contracting with an environmental consultant to prepare all necessary environmental documents, in consultation with the Community Development Department, Planning Division. To facilitate this process, the City has established a Qualified Environmental Consultants List, from which applicants must select and retain an environmental consultant. The consultants included on the list have responded to the Request for Qualifications (RFQ) for Placement on Qualified Environmental Consultants List and have submitted a Statement of Qualifications (SOQ) that was evaluated by City staff, determined to meet the minimum qualifications, and are considered qualified to prepare environmental documents. SOQ submittals are available on the City webpage. The requirement to be on the list does not extend to sub-consultants. The list does not represent an endorsement of any specific environmental consultant or individual. The consultants included on the list are identified in alphabetical order.
