

Community Services Program Day Camp Participant Participation Rules Related to COVID-19 Coronavirus

The following rules, in addition to the regular program participant rules, are in place until further notice due to COVID-19 Coronavirus. If you or your child are found in violation of these rules, you or your child may be removed from a program immediately and not allowed to continue. If you or your child are removed from a program for violating the rules, your fees will not be refunded.

1. Participant numbers in each camp program will be limited to 10 for each program.
2. All participants must provide their own face covering for the program. All participants must have a face covering on while in the program and interacting with fellow participants and City staff.
3. All parents/guardians must have a face covering on while interacting with fellow participants, parents/guardians, and City staff.
4. All participants and parents/guardians must use social/physical distancing and stay 6 feet apart from others at all times.
5. All participants must provide a personal plastic bin with a lid to store their belongings in during the day. The bin will go home with the participant at the end of each day.
6. Participants will undergo a health screening and temperature check prior to entering camp each day.
7. Public drinking fountains will not be able to be used so participants should bring enough bottled water for themselves to camp each day to meet their hydration needs.
8. Because snacks cannot be shared or provided by City staff, participants must bring their own snacks to camp each day (there are two snack periods). Lunch must also be brought each day.
9. Except for family members living in the same household, you are asked to maintain social distancing in parks, buildings, parking lots, pathways and hallways and where required by the program.
10. Participants will be asked to frequently wash their hands throughout the day. Parents/guardians and participants should wash their hands or use sanitizer immediately before entering and after leaving the program.
11. Please follow the instructions provided by the staff supervising and leading the Day Camp program.
12. Parents/guardians will not be physically signing their children in and out each day on our daily roster. One staff member will be responsible for doing this when parents drop off and pick up their children.
13. After the program is completed, please leave the building and park premises and do not congregate.
14. Parents/guardians are required to review and sign the waiver on the other side of this form before their children will be allowed in the program.

Assumption of Risk / Waiver and Release for Communicable Diseases including COVID-19

COVID-19 has been declared a worldwide pandemic by the World Health Organization and is extremely contagious and is believed to spread mainly from person-to-person contact. As a result governments and health organizations recommend face coverings and social distancing. The City of Torrance has put in place preventative measures to reduce the spread of COVID-19 and other communicable diseases. However, the City cannot guarantee that your child (the participant), you, or your family will not become infected with COVID-19 or other communicable diseases. Further, engaging in the Day Camp program could increase the participant's, you or your family's risk of contracting COVID-19 and other communicable diseases.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and other communicable diseases and voluntarily assume the risk that my child, myself and/or my family may be exposed to or infected by COVID-19 or other communicable disease by participating in program activities and/or being on park property and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 or other communicable disease may result from the actions, omissions, or negligence of myself and others, including, but not limited to, City of Torrance, its City Council, each member thereof, present and future, its officers, agents, employees, and volunteers . I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child, myself and family including but not limited to, personal injury, disability, illness, and death, that I or my family may experience or incur in connection with my child's attendance in the Day Camp program.

In return for the Participant being allowed to enter and remain in Torrance Day Camp and participate in activities in connection therewith, I hereby release, covenant not to sue, discharge, and hold harmless the City of Torrance, the City Council, each member thereof, present and future, its officers, agents, employees, and volunteers from any and all claims including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating to my participation in the Day Camp program, including but not limited to COVID-19 exposure or infection.
