Description of Work (if the project includes tile or shake, include the manufacturer, ICC #, type and weight)

NOTE: APPROVED COOL ROOFING MATERIAL IS REQUIRED OVER ALL CONDITIONED SPACE UNLESS:

1. Roof area covered by building-integrated solar panels, or
2. If the roof weight is more than 25 lb/ft², or
3. If the existing roof is rock/gravel, the new roof is rock/gravel, no removal of existing roofing, no recoating and no installation of insulation or other substrate.

NOTE: R-8 INSULATION REQUIRED IF 50% OR 2,000 SF REROOF AREA WITH EXPOSED ROOF DECK UNLESS:

1. Existing roof has R-7 or U=.089, or
2. Reduced insulation if roof equipment to remain in place, or
3. Reduced insulation to maintain 8" base flashing ht, or
4. Insulation may be tapered at drains and lowpoints provided it is increased at high points to maintain average thermal level.

To save you time and effort, **do not load roof** prior to reading the following:

- a) An application for permit must be submitted and a PRELIMINARY INSPECTION may be required before a permit will be issued.
- b) All contractors must have a copy of a current Workers' Compensation insurance certificate on file before a permit can be issued.
